Discovering Catholic Charities, Diocese of Trenton's (CCDoT) behavioral health services marked a turning point for Jean. Living with mental illness, she

had experienced many dark, difficult days. Her prior experiences with treatment were not all positive.

"The approach at Catholic Charities was different," she said. "I was treated as a whole person." Jean saw a psychiatrist and a clinician. She also joined a therapy group for women. In 2016, when the group was discontinued, she joined the Riverbank Self-Help Center, where she could learn and share with others on a similar journey.

At the Self-Help Center, Jean learned about Peer Advocates and completed training to become one. She has earned her credentials as a Peer Recovery Specialist and is currently working to become a Certified Drug and Alcohol Counselor. When the opportunity to become a driver at the center became available, she took it. The job gave her the confidence to apply for and land a position as a Mental Health Peer Advocate on one of CCDoT's Program of Assertive Community Treatment Teams.

Since working with CCDoT, Jean has become a strong advocate for people with behavioral health diagnoses. She has shared her story with Catholic Charities USA. She also participated in a New Jersey Association of Mental Health and Addiction Agencies, Inc. campaign calling for significant increases in funding for behavioral health services.

In the wake of devastating Super Storm Sandy that ravaged New Jersey in 2012, Brick Township faced unprecedented challenges.


Amid chaos and destruction, Christie Winters mobilized a team of dedicated volunteers and in 2014, Seeds of Service (SOS) was born.
